News Highlights:

- There are mixed reactions to the U.S. Food and Drug Administration's decision to provide **temporary flexibility in food labeling requirements** during the coronavirus pandemic. In cases where substitutions of ingredients can be made safely, the FDA is now allowing food companies to do so without making changes to the ingredient labels. The food manufacturing industry asked for the change in order to keep up with production demand, but some consumer advocacy groups are concerned about food safety. There are also concerns that this could end up being a long-term policy change.

- The FDA announced a pending recall of at least five companies' extended-release (ER) generic formulation of metformin, a prescription drug used to control high blood sugar in patients with type 2 diabetes. The recalls are due to evidence of unacceptable NDMA (carcinogen) levels. Apotex Corp's 500 mg extended release formula was the first product listed. More than 20 companies make generic metformin, and it is one of the most-prescribed drugs in the U.S. Glucophage is a common brand name version.

- The FDA's testing of metformin was triggered by independent pharmacy Valisure's citizen petition filed March 2 alerting the FDA that 11 out of 22 companies selling metformin had NDMA levels detected above the 96 nanograms (ng) daily acceptable intake limit, based on their testing.

- Some lots of Acella's **hypothyroid** treatment **NP Thyroid** are being recalled because of "**superpotency**." The product may have up to 115% of the labeled amount of **Liothyronine (T3)**. Superpotency in the drug may cause weight loss, heat intolerance, fatigue, muscle weakness, hypertension, chest pain, rapid heart rate, or heart rhythm disturbances. NP Thyroid is a natural-derived (porcine) treatment. While it requires a prescription, it is not an FDA-approved drug. The drug is similar to <u>Armour Thyroid</u> (click for reviews).

- The U.S. Food and Drug Administration granted approval to Astellas Pharmaceutical's **VESIcare LS** (solifenacin succinate) oral suspension, a liquid taken by mouth, for treatment of neurogenic detrusor overactivity (NDO) in **children 2 and older**. NDO is a form of **bladder dysfunction** (similar to overactive bladder) that results from disease (such as spina bifida) or injury in the nervous system. VESIcare (solifenacin succinate) tablets were initially approved in 2004 for the treatment of overactive bladder in adults 18 years and older.

- Additional drugs used to treat **overactive bladder** include antimuscarinic drugs, Beta-3 Agonists, Alphablockers, and botulism therapy (Botox). Hormone-related changes related to **menopause in women** and agerelated **BPH (enlarged prostate) in men** are considered to be contributing factors to the condition. - Tauvid, a new diagnostic drug administered by IV, was approved by the FDA to identify the presence of tau proteins in the brain. Two proteins tau and amyloid are recognized as hallmarks of Alzheimer's disease. - Nuro Company's autonomous "pod cars" have partnered with CVS to begin making prescription deliveries in the Houston area across three ZIP codes starting in June.
